Cynhelir yr ysgol gan Gyngor Sir Ceredigion.

Cynhaliodd Gyngor Sir Ceredigion gyfnod ymgynghori cyn penderfynu cyhoeddi'r cynnig hwn. Mae adroddiad ar yr ymgynghoriad sy'n cynnwys crynodeb o'r materion a godwyd gan ymgynghoreion, ymatebion y cynigydd ac ymateb llawn Estyn ar gael ar wefan Gyngor Sir Ceredigion (www.ceredigion.gov.uk)

Cynigir gweithredu'r cynnig ar y **31 Awst 2019**.

Ni fwriedir i ymgymryd ag unrhyw fesurau eraill i gynyddu nifer y lleoedd sydd ar gael mewn ysgolion o ganlyniad i'r cynnig i gau'r ysgol.

Darperir Cludiant o'r Cartref i'r Ysgol yn unol â Pholisi Cludiant o'r Cartref i'r Ysgol a fydd mewn grym ar ddyddiad gweithredu'r cynnig.

Gweithredu'r cynnig i derfynu'r ddarpariaeth addysg yn Ysgol Gynradd Gymunedol Trewen yw'r ymateb mwyaf priodol wrth fynd i'r afael â'r rhesymau a nodwyd wrth lunio'r cynnig oherwydd y ffactorau a ganlyn:

- Caiff y disgyblion eu haddysgu mewn dosbarthiadau o ystod oedran agosach yn yr ysgol amgen
- Bydd cynnal darpariaeth ar wahân yn y cyfnodau allweddol yn fwy tebygol
- Byddai'r gost fesul disgybl yn Ysgol Cenarth yn lleihau petai nifer y disgyblion yn cynyddu
- Byddai addysg feithrin ar gael
- Mae lleoedd gwag yn Ysgol Cenarth i dderbyn pob disgybl o Ysgol Trewen.

Statutory notice to discontinue Trewen Community Primary School

Notice is given in accordance with section 43 of the School Standards and Organisation (Wales) Act 2013 and the School Organisation Code that Ceredigion County Council, having consulted such persons as required, propose to discontinue **Trewen Community Primary School, Cwm Cou, Newcastle Emlyn, SA38 9PE**. The school is currently maintained by Ceredigion County Council.

The Local Authority undertook a period of consultation before deciding to publish this proposal. A consultation report containing a summary of the issues raised by consultees, the proposer's responses and Estyn's full response is available on Ceredigion County Council's website (www.ceredigion.gov.uk)

It is proposed to implement the proposal on **31 August 2019**.

As from the 1st September 2019, subject to parental choice, it is proposed to transfer pupils who would normally have attended Trewen Community Primary School to the following school which is a Welsh medium school:

- Cenarth Community Primary School, Cenarth, Newcastle Emlyn, SA38 9JP.

No other measures are proposed to be taken to increase the number of school places available in consequence of the proposed discontinuance.

Home to School transport will be provided in accordance with the Authority's Home to School Transport Policy as at the date of implementation.

The implementation of the proposal to discontinue the education provision at Trewen Community Primary School is the most appropriate response to address the reasons identified in formulating the proposal due to the following factors:

- Pupils will be taught in closer age range classes in the alternative school
- A stronger likelihood of provision being maintained separately in the key stages
- There would be a reduction in the cost per pupil at Cenarth School if the number of pupils increase
- Nursery education would be available
- There is surplus capacity at Cenarth School to accept all the pupils from Trewen School.

Within a period of 28 days of the date on which the proposal was published, that is to say by **6 February 2019** any person may object to the proposal.
